This is an Associate role that is partner-track position. The SaaS Applications Developer will design programming specifications in conjunction with the company. Position

Brief description

The position of SaaS developer consists of developing custom applications, programming, planning, directing, and coordinating all activities associated with creating and implementing solutions for multiple functional areas of the apps. Prioritize company requirements such as solidifying strategy, tactics, business model, and schedule. To fulfill the requirements of the company by custom programming which will be delivered with operation performance (OPE) as per specifications. Allocate projects representing the operation or workflow, and resources with the assistance of identified architects and engineers. Design acceptance tests for releasing the minimum viable product.

Tasks

- Designs programming specifications in consultation with the company.
- Provides vision, planning and coordination of all SaaS development and/or implementation activities.
- Establishes standards in application development and integration and if company does not approve, Developer and Company will restart the procedure.
- Participate in the strategic decisions about technology, definition, and implementation of the SaaS solutions.



- Prioritize, budget, and allocate projects, products, and resources in line with business priorities.
- Prepare project business cases in collaboration with stakeholders.
- Apply Project Management best practices to meet project plan timeline, budget, and scope objectives.
- Drive overall architecture, define application security guidelines and certifications of SaaS business solutions.
- Ensure, SaaS engineering best practices, methodology and procedures are used to ensure reproducible development/implementation of high quality while keeping costs under control.
- Implement and run evaluation procedures to assess risks in the current schedule, clear blocks, and adjust roadmap deliverables.
- Manage SaaS Quality Assurance striving to achieve a high level of quality and independent verification of SaaS reliability.
- Implement process improvement programs and efficiencies such as scoring tools or system.
- Promote the use of innovative technologies that will provide benefits to the organization.
- In association with the company client, lead the introduction of the new technologies, and web applications.
- Create and manage an application support help-desk service.

Qualifications and requirements

- A bachelor's degree or its equivalent in a field connected to IT/computers.
- Capability to identify difficult problems and study pertinent data to design, assess, and implement solutions.
- Capacity to pay close attention to what others are saying and to recognise the strengths and flaws of different alternatives using logic and reason.
