LESSON

- Silver Seals season – between August and April/May
- The School will be closed on all public holidays and Islamic Religious holy days. These lessons will not be reimbursed
- However, if the cancellation is from Silver Seals Swimming School then such lessons will be accommodated as best as possible.
- N.B. If any lessons are missed during the month, only 1 lesson per month will be offered in return for that month. Lessons missed, cancelled or not attended for personal reasons will also not be reimbursed
- NO CATCHUP CLASSES UNLESS WE HAVE VERIFIED PROOF OF AN EMERGENCY OR ILLNESS, E.G. POLICE AFFIDAVIT OR DOCTOR'S LETTERS.
- Kindly notify the School of non-attendance.
- During rainy days, lessons are still held. Precaution is taken in the event of lightning. Lessons cancelled by us for lightning will not be made up.
- **NO PARENT ALLOWED ON POOL DECK**
- **If a learner misbehaves or disrupts a lesson, he/she will be given a warning. Should the learner persist with bad behaviour, he/she may be requested to leave the lesson. This is to ensure SAFETY at all times.**
- **The Learners may not run around the pool area nor enter the pool without the teacher's permission.**

FEES

- Registration Fees are payable at the beginning of every swimming season. Fees are due on or before the 15th of every month.
- Registration fee is used for the maintenance and running of daily needs at the school.
- Fees cover 8 lessons (twice weekly) or 4 lessons (once weekly/Saturdays only). If a learner joins before the 15th then a full month's fee is due, and if the learner joins after the 15th only half month's payment will be due. A reminder, the 5th lesson or 9th lesson a month are bonus classes to the learner.
- Payments are required on a monthly basis and under no circumstances will individual lesson payments be allowed.
- A full calendar month notice and one month's fees in lieu of notice must be submitted before terminating lessons.
- An increase in fees will take place annually at the beginning of each season.
- Payment reminders will sometimes be sent out via SMS, WhatsApp or Email.
- Fees are discounted for December & January each year.
