
PROVIDING ACCESS TO SURGERY

For our patients without health insurance, access to surgeries is either impossible due to cost or they incur great financial stress if the surgery is necessary because it has reached an emergency state. Either situation devastates a patient and contributes to worse continue the patient on with their treatment. In 2022, the surgeries and diagnostic testing ranged from hernia and gallbladder biopsies, hysterectomies, traumatic cataract surgery and more. The fund was named in memory of Victory's first partner and surgeon, Dr. William M. Lightfoot.



CRITICAL ACCESS TO **PSYCHIATRIC CARE**

With access to affordable and quality mental healthcare being one of the top needs identified within our community and nation, a significant partnership in 2022 was when Dr. Carlos Diaz joined Victory to provide psychiatric care to patients for no cost. With this new resource, Victory Health physicians are able to collaborate and consult with Dr. Diaz as needed.



Victory Health now offers a clinic once per month on Saturdays for patients needing psychiatric care.

HEALTHY EMPLOYEES ARE THE BEST ASSET FOR A HEALTHY WORKFORCE

We know not every company can offer health insurance coverage; not every employee can afford to take health insurance offered by their company, and some employees don't qualify for their company's coverage. We also know a healthy workforce impacts a company and is vital to the workplace. Health is a state of complete physical, mental and social well being. Employees need to be healthy to feel good. Only then will they perform their best and also encourage others around them. The easiest way to encourage employee health is for a company to introduce health initiatives.

In 2022, Victory Health developed an Employee Healthcare Resource packet that made it easy for companies to introduce a healthcare option for their workforce who are uninsured.

Companies like Piggly Wiggly, Greers, and Goodwill Gulf Coast, along with many others, utilized the packet during the on-boarding process of new employees and made it available to current employees. This allowed the employee to have access to a full spectrum of compassionate, affordable and comprehensive healthcare at Victory Health.

PATIENT ASSISTANCE PROGRAM: PROVISION OF FREE PRESCRIPTION MEDICATIONS

The Dispensary Program enables Victory patients receive all or most of their medications at no charge. Due to the arduous process of enrollment into the pharmaceutical companies' patient assistance programs, we enroll our patients into these programs on their behalf.

One example is the provision of medication and laboratory work for patients who test positive for Hepatitis C. The 300 patients who have completed the treatment have all been cured of their Hepatitis C. The cost of the medication and treatment is over \$70,000 per patient. The patients receiving this care have no cost for their medication

In total for 2022, Victory provided over \$63.3 million worth of free medication to patients through our Medication Assistance Program. This is significant as 1 in 4 uninsured adults could not afford filling a drug **prescription** this past year and the same proportion went without recommended tests or treatment due to cost.

Victory orders medication from over 25 pharmaceutical companies' patient assistant programs. The companies below highlight the programs Victory has been able to secure the highest volume of medications for our patients.



THE NEXT GENERATION: BREAKING DOWN BARRIERS

The Alabama Zeta Chapter of AED at the University of South Alabama has partnered with Victory Health Partners and has provided triage volunteers for the clinic for several years. In 2022, Victory AED volunteers noticed there were a number of patients who do not speak English as their first language and at times created a barrier between patients and their providers. In order to break down this barrier and extend medical care to a wider range of individuals, AED coordinated with their bilingual pre-health students to create a group that would be able to translate for patients during clinic visits. This has helped patients to become more comfortable in the clinic and has allowed Victory to see patients that otherwise could not
