WHAT IS DOCUSIGN?

Document-signing software is technology that lets you sign documents online. It uses an electronic signature and requires no paper, printing, scanning or faxing of your document used to replace lengthy manual signing processes, e-signatures speed the agreement process and maximize productivity. At Only Realty we use Docusign to send off all of our Mandate Agreements and Leases.



SENDING YOUR FIRST MANDATE AGREEMENT?

When logged into DocuSign the first thing you'll see is the Main Dashboard.



Click on the Templates Tab to view all of the Mandates & Lease Agreements.

On the DocuSign Dashboard the only sections that you will use as an agent is the "Manage Tab" and the "Template Tab". The Manage tab is where we can you can track all of your documents sent out, you can also manage and track whether a Tenant or Landlord has signed and viewed your Document. The Template Tab is where you will you find all of templates to create your Documents. Let's start by creating and sending out our first Mandate Agreement.



Find the agreement you need and ONLY CLICK THE USE BUTTON. You do not want to the check the box or edit the document if you do it will edit the agreement for everyone!
