

Waiver:

In consideration of First Taekwondo, located at 17310 Yonge St Unit 2A ("First Taekwondo"), granting any and all children (each a "Child" and together with the "Children") who enter First Taekwondo's facility (the "Facility") under the direct or indirect supervision of the undersigned, the right to use the Facility, I hereby, on behalf of myself, my Child/Children, my Children's heirs, executors, administrators, or anyone who might claim on their behalf, warrant and agree as follows:

I represent and warrant that I am the parent or legal guardian of the below-named Child/Children. I will be responsible for the supervision of the Child/Children.

By entering First Taekwondo, I acknowledge and am fully aware of the inherent risks present in an indoor play environment. The equipment and its use can be dangerous and may result in serious injury to me and/or my Child/Children, including damage to personal property, personal injury, or death.

I hereby knowingly and voluntarily assume and accept all risks, including all presently unknown or unforeseeable risks, and assume all responsibility for risks to myself, my Child/Children, my personal property, and the personal property of my Child/Children upon signing this Waiver.

I warrant and represent that I have read the First Taekwondo Rules (the "Rules"), which form part of this Waiver. I agree to and shall ensure my Child/Children use First Taekwondo only in accordance with the Rules. I acknowledge that failure to abide by the Rules or to use the equipment in a safe and appropriate manner may, at the sole discretion of First Taekwondo, result in my or my Child's/Children's removal from the Facility.

I give First Taekwondo permission to use pictures taken of my child for promotional use.

I understand and agree that First Taekwondo, its shareholders, officers, directors, employees, management, contractors, agents, or other representatives (the "Representatives") shall not be liable for any injury, damage, or loss that I or my Child/Children may suffer as a result of using the Facility. I understand and agree that First Taekwondo and its Representatives are not responsible for the supervision of my Child/Children and shall not be held liable for any reason whatsoever for failing to supervise my Child/Children, including child disappearance.

I hereby release, waive, and forever discharge First Taekwondo and its Representatives from any and all liability, claims, demands, losses, or damages, however caused, whether related to property damage, theft, and/or personal injury (including death), and whether based on tort, intentional act, strict liability, negligence, and/or negligent rescue, that I or my Child/Children may suffer as a result of my Child/Children using the Facility, including as a result of the negligence of First Taekwondo or its Representatives. I will indemnify, save, and hold harmless each of First Taekwondo and its Representatives from any and all claims, expenses, legal fees,

losses, liabilities, damages, or costs which relate to or arise from this Waiver, to the fullest extent permitted by law.

If my Child/Children is a minor, I, the undersigned parent or guardian, hereby give permission for First Taekwondo to authorize emergency medical treatment as may be deemed necessary for the Child/Children named below while participating in activities at the Facility. I hereby release, discharge, covenant to bring an action, and agree to indemnify and save harmless First Taekwondo from all liability, claims, demands, losses, or damages on the Child's/Children's account caused or alleged to have been caused in whole or in part by the negligent medical treatment, failure to provide medical treatment, and further agree to indemnify, save, and hold harmless First Taekwondo and its Representatives from any liability whatsoever as a result of any such claim.

I represent and warrant that my Child/Children are in good physical condition and physically able to play in the Facility and that my Child/Children are old enough to participate.

I agree and acknowledge that my execution of this Waiver on the initial visit, or for one of my Children, authorizes First Taekwondo to enter this Waiver into its database and use it as a continuous, multi-use waiver for my Child's/Children's ongoing entry to play in the Facility or use it as a Waiver executed for my other Child/Children. I hereby expressly authorize First Taekwondo to use this Waiver as a multi-use waiver until such time as I revoke it in writing.

I agree and acknowledge that First Taekwondo shall use reasonable efforts to ensure that the Facility is a nut-free facility; however, due to numerous factors outside its control, First Taekwondo makes no guarantee, warranty, or representation that the Facility is a nut-free facility. I accept any and all risks that this may cause for my Child/Children.

If I opt not to sign the waiver, then I will not be allowed to enter the First Taekwondo facility.

Rules:

All people must be supervised by a responsible adult or caregiver at all times. A responsible caregiver is someone who is a minimum of 16 years old.

For the safety of our youngest Participants, walking is always encouraged.

First Taekwondo is not responsible for any lost or stolen items.
