# CAMP FOR FREE DISTRIBUTION OF SANITARY PADS TO UNDERPRIVILEGED GIRLS

women's hygiene is as concerned, access to medically approved safe sanitary pads has headlines, always been in the especially in a country like India where menstruation is tagged with certain taboos and social restrictions. Out of a total of ~40 crore menstruating women in India, less than 20% use sanitary pads. In urban areas, this number only goes up to Other than Economic insufficiency, lagging in awareness as well as ignorant attitude of this patriarchal mindset are the prime reasons behind acceleration women hygiene related diseases in India.

At any point of time, poor girls/women across India cannot buy sanitary napkins. Instead, they use cloth, grass, newspaper, and other unhygienic material which increases their risk of infection.

It is estimated that more than 80% of women in India do not have access sanitary products during to Zameen Tare menstruation. Foundation has distributed free sanitary pads among girls/women at Sambhav Camp JJ Colony area of Palam Vihar, Delhi on 3rd and 15th April and later on 5th and 18th May & 25th December of the year 2019. The doctor team had educated and made them aware of their health and benefits of sanitary pads and how to become disease-free, and hygienic. Our mission is to raise awareness of gender issues and bring it out in the open. Through our programs, we teach young girls/women that their menstrual cycle is natural, a sign of good reproductive health, and is something that girls in countries around the world have in common! Free distribution will be done every month among girls/women in Delhi NCR.

Through our programs, we aim to improve the health and quality of life of girls and women across the country.

Menstrual hygiene management (MHM) or menstrual health and hygiene (MHH) is about access to menstrual hygiene products to absorb or collect menstrual blood, privacy to change the materials, and access to facilities to dispose of used menstrual management materials. It can also include the "broader systemic factors that link menstruation with health, well-being, gender equality, education, equity, empowerment, and rights". Menstrual hygiene management can be particularly challenging for girls and women in rural areas, where clean water and toilet facilities are often inadequate. Menstruation can be a barrier to education for many girls, as a lack of effective sanitary products restricts girls' involvement in educational and social activities.

Keeping all these facts into account, Tare Zameen organized Awareness on menstrual hygiene and Health Education through eco-friendly sanitary napkins" On 24th January 2020 in Sahoday School. #### WORKSHOP ON 'BEHAVIOR CHANGE AMONG CHILDREN'

Normal behavior in children depends on the child's age, personality, and physical and emotional development. A child's behavior may be a problem if it doesn't match the expectations of the family or if it is disruptive. Normal or "good" behavior is usually determined by whether it's socially, culturally, and developmentally appropriate. Knowing what to expect from your child at each age will help you decide whether his or her behavior is normal.

Remember, no child has perfect behavior. Your child's doctor, preschool, and school will be helpful in setting expectations for your child and his or her age and development. Many things can cause a child to have temper tantrums, emotional outbursts, and general "bad" or unexpected behavior.

These can include biological reasons, like being hungry or overtired. It can include communication issues related to learning challenges. It also can include emotional reasons, like not being able to cope with or describe their feelings. Their environment can also influence behavior.

A delightful and enlightening children's workshop was organized by Tare Zameen Foundation in association with Team Adakari of Daulat Ram College on 14th March (2-5 PM) at Babu Camp, New Delhi.

Around 200 children were a part of it where children were taught various aspects of behavior through dance forms and changes in voice and expression through Lok Natya. The event was fun and interactive.
