Paxil Kayalá, Lajuj K'at / Guatemala, June 16, 2022

The Ajq'ijab', Indigenous Authorities and organizations of the Mayan, Xinka and Garífuna people, before national and international public opinion, announce the following facts:

In response to the demand of the united organizations of Ajq'ijab', last May 11, in which they requested the total repeal of the law, the total repeal of the initiative of law No. 5923 entitled "Rescue of the Pre-Hispanic Heritage" of Guatemala, which was presented to the Shirley Rivera, president of the Board of Directors of the Congress of the Republic of Guatemala, pointing out that this initiative of law No. 5923 entitled "Rescue of the Prehispanic Heritage" of Guatemala, pointing out that said law initiative is considered "racist", "discriminatory", "exclusionary", "privatizing", and that it does not recognize the rights of the people of Guatemala, "privatizing" and that it ignores and invalidates the conventions and international treaties of Human Rights that have been accepted and ratified by the State of Guatemala.

Following the mobilization of 11 May, on May 19, several structures of indigenous authorities were present at the congressional Congress to deliver another memorial, in the same terms as the previous petition, which was received by the president was received by the President of the Cultural Commission of the Congress, Mrs. Sandra Lorena de León Teo, in the presence of several members of the Indigenous Peoples Commission.

Our reading of the decisions and actions taken by Congresswoman Shirley Rivera is that she wants to wear us down in the wait and while waiting and while they design their strategies on how to approve said bill 5923. In view of her delaying actions. We can tell you that we have more than five hundred years of resistance and struggle, we will continue to defend and demand the exercise of our rights over the millenary cultural heritage of the Maya people and other peoples.

We reaffirm our resounding rejection of bill 5923. We demand that it be discarded, due to the aforementioned characteristics mentioned above, because if it is approved, it puts at risk of extermination the knowledge system of the peoples, of the peoples associated to the sacred places and territories, as such it is part of the history of the dispossession and destruction, that are designed on the lives of indigenous peoples.
