Participation Agreement and Consent

THIS AGREEMENT IS TO BE COMPLETED BY THE STUDENT AND **PARENT PRIOR TO PARTICIPATION** IN COVENANT ATHLETICS. THE COMPLETED FORM WILL BE KEPT ON FILE BY THE SCHOOL.

Athlete Agreement

- I understand that participation in sports is a privilege and that no exceptions will be made for me on the basis of my participation.
- I will maintain a C average or better in all of my classes. I understand that failure to maintain these academic standards may result in academic probation, and I will not be allowed to participate in sports until my teachers and coaches agree to allow me to participate again.
- I understand that, as an athlete, I represent my family, my team, my coaches, and my school. As such, I will conduct myself in a Christian manner on and off campus, exhibit good sportsmanship during competitions, obeying my parents, teachers, and coaches to the best of my ability. I understand that failure to conduct myself appropriately can cost me the opportunity to participate.
- I understand the risks involved with participation in athletics, and I accept those risks. I agree to report any injury, as well as any professional medical advice or instruction related to the injury, to my coaches as soon as possible. I understand that it is my responsibility to follow the advice of a medical professional for the best recovery from an injury.
- I will be on time and dressed appropriately for every athletic event. Failure to do these things can result in reduced playing time or disciplinary action.
- I will follow instructions from my coaches. I will practice with intense effort and focus, striving to improve daily. I will be a positive influence on my teammates at all times. Failure to do these things can result in reduced playing time or disciplinary action.
- I understand my coach's aim is to provide as much playing time as possible during games, but playing time is not guaranteed.
- I will return my uniform to the school within two weeks after the end of the season. Failure to do this may result in a fee on my Covenant account (up to \$75).

Parent Agreement

- I consent my child to participate in sports at Covenant Christian School.
- I understand that participation in sports is a privilege and that no exceptions will be made for my son/daughter based on his/her participation or abilities.
- I agree to read all communications sent out regarding the athletic department in regard to my child's participation in sports. Communications include but may not be limited to emails, ParentAlert texts, or another method chosen by the coach or athletic director. These communications may contain important information regarding schedule changes in practices, games, or other pertinent information.
- I authorize emergency medical treatment for my child should the need arise for such treatment while they are under the supervision of the school.
- I will pay the necessary athletic fees and game admissions costs to help Covenant Athletics cover operational expenses and promote the program's growth.
- I will make every effort to participate in Covenant's annual fundraising event during the Spring Semester. Parent-initiated fundraising efforts must be approved by the Athletic Director before any promotion is made.
- I will make every effort to ensure my child is on time and dressed appropriately for every athletic event, including practices. I will avoid, when possible, scheduling appointments and/or travel that take them away from these events. I understand that practice time missed can result in reduced playing time, regardless of the circumstances.
- I will teach my child to respect their coaches and the officials, follow their instructions, honor their teammates and competitors, and put the team before themselves. I will teach my child to prioritize daily improvement over winning games.
- While attending any Covenant athletic event, I will conduct myself in a manner consistent with the mission statement of Covenant Christian School. I will always remain civil towards fans, coaches, referees, and players. Furthermore, I will help maintain an environment of honor and respect for all present. I will wait 24 hours after an athletic event to take up any dispute with a Covenant Coach over something that occurred during that event.
- I understand that the coaches aim to provide as much playing time as possible during games, but playing time is not guaranteed.
- I will ensure that my child turns in their uniform to the school within two weeks after the end of the season. I understand that failure to do this may result in a fee on my Covenant account (up to \$75).
