

## Terms and Conditions of Purchase for Chat GPT Skool

**Payment:** The full price for Chat GPT Skool is currently \$497, payable by any major credit or debit card or PayPal unless it is on sale or a coupon code used.

**Access:** Customers will be able to access the course immediately after purchase via our online learning platform on Skool.com/chatgpt

**Disputes with Credit Card Companies:** In the event that a customer initiates a dispute with their credit card company regarding a transaction related to our course, the customer's access to the course will be temporarily suspended until the dispute is resolved.
