Dear Sir/Madam,

With reference to the captioned subject and as per Regulation 31A(9) & 31A(7) of Securities and Exchange Board of India (Listing Obligation Disclosure Requirements) Regulations, 2015 and amended thereto, it is hereby informed to the exchange that:

1. The Resolution Plan as submitted by Mr. Sharad Sanghi and as approved by the Committee of Creditors of Jyoti Structures Ltd. was approved by Hon'ble NCLT, Mumbai Bench through the Order dated March 27, 2019 (“Plan Approval Order”).
2. However there has been delay in initiation of implementation of the Approved Resolution Plan. On the advice of the lenders of the Company, the Resolution Professional (“RP”) has filed an application before Hon'ble Bench for seeking direction on implementation of the Approved Resolution Plan.
3. In terms of Section VII (C) of the Approved Resolution Plan “The Company will not remain any individual or family run company and it is proposed that the Company will become board controlled and professionally managed. The Founder Promoters will neither be allotted any equity shares nor be on the board of the Company. The Proposed Investors will not be deemed/classified as promoters of the Company. The Company shall ensure that during the implementation of Final Resolution Plan, classification of any person as “Promoter” of the Company under the regulations prescribed by the Securities Exchange Board of India shall only be with the prior approval of the secured financial creditors of the Company”.
4. Hon'ble NCLT, Mumbai Bench through the order dated January 2021 directed the RP to file application for making the Company a promoter-less in compliance to the provisions of the Approved Resolution Plan as stated above.
5. Accordingly, the Company is in receipt of request (NOC) letters for reclassification of the shareholding from “Promoter and Promoter Group” to “Public” category in order to make the Company “Promoter-less” under the Provision of the said regulation from each of the following shareholders of the Company. This will help in paving way for implementation of the Approved Resolution Plan.
