- The Company completed on 12th May 2014, the dispatch of postal ballot forms alongwith notice and postage prepaid business reply envelope to its members whose name(s) appeared on the Register of Members/list of beneficiaries on 2nd May 2014
- 2. Particulars of all the Postal Ballot forms received from the Members have been entered in a separate register maintained for the purpose.
- The Postal Ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.
- 4. The Ballot box was opened on 12th June 2014 in my presence.
- 5. The Postal Ballot forms were duly opened in my presence and were scrutinized. The shareholding mention on forms by shareholders was confirmed with the Register of Members of the Company/ list of beneficiaries as on 2nd May 2014.
- 6. All postal Ballot forms received upto the close of working hours (i.e. 5.00 p.m.) on 11th June 2014, the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.
- 7. No envelopes containing Postal Ballot forms received after 11th June 2014.
- 8. The results of e-vote casted by the shareholders through e-voting facility have been downloaded from e-voting website www.evotingindia.com in my presence and consolidated with results of postal ballot by me.
